CANCELLATION AND REFUND POLICY:

A cancellation before November 27, 2017 will receive a full refund less a Tango at Sea \$150pp USD administration fee.
Passengers, who cancel after that date for any reason, including medical reasons, are subject to the fees set by MSC Cruise Lines as follows:

- \$400 USD pp deposit fee for any cancellation from November 28, 2017 thru December 26, 2017
- 50% of cruise fare in USD for any cancellation from December 27, 2017 thru January 9, 2018
- 75% of cruise fare in USD for any cancellation from January 10, 2018 thru February 9, 2018
- 100% of cruise fare in USD for cancellation from February 10, 2018 to date of sailing

PLEASE NOTE:

MSC insurance is available up to 75 days prior to sailing to US and Canada citizens. Tango at Sea offers Door to Door travel insurance through Allianz Travel Insurance to citizens in the USA. REFUNDS: Requests must be made in writing by email ONLY. Processing time for refunds will occur after the sailing ends on March 8, 2018. Deposit receipt, cruise tickets, airline tickets, transfer coupons and all other vouchers must be returned to Tango at Sea before a refund can be made. In most cases the refund will be processed via Tango at Sea company check. Administration fees must be paid to Tango at Sea Agency before cruise cancellation can be completed.
