**CANCELLATION AND REFUND POLICY:**

A cancellation before December 3, 2019 will receive a full refund less a Tango at Sea \$150pp USD administration fee.

Passengers, who cancel after that date for any reason, including medical reasons, are subject to the fees set by MSC Cruise Lines as follows:

- **\$400 USD per person** deposit fee for any cancellation from December 4, 2019 thru January 1, 2020
- 50% of cruise fare in USD for any cancellation from January 2, 2020 thru January 18, 2020
- 75% of cruise fare in USD for any cancellation from January 19, 2020 thru February 15, 2020
- 100% of cruise fare in USD for cancellation from February 16, 2020 to date of sailing

**PLEASE NOTE:**

MSC insurance is available up to 75 days prior to sailing to US citizens. Tango at Sea offers Door to Door travel insurance through Allianz Travel Insurance to citizens in the USA. Premiums are based on cost of travel plus the age of the traveler. Full details are listed under the Travel Insurance tab on our website. **Our guests are required to carry travel insurance.**

**REFUNDS:** Requests must be made in writing by email ONLY. Processing time for refunds will occur after the sailing ends on March 10, 2020. Deposit receipt, cruise tickets, airline tickets, transfer coupons and all other vouchers must be returned to Tango at Sea before a refund can be made. In most cases the refund will be processed via Tango at Sea company check. Administration fees must be paid to Tango at Sea Agency before cruise cancellation can be completed.
