CANCELLATION AND REFUND POLICY:

A cancellation before December 7, 2025 will receive a full refund less a Tango at Sea \$150pp USD administration fee. Passengers, who cancel after that date for any reason, including medical reasons, are subject to the fees set by Costa Cruise Lines as follows:

- \$50 USD per person until 90 day date for administrative fee;
- 30% of cruise fare in USD for any cancellation from December 8, 2025 thru January 6, 2025
- 60% of cruise fare in USD for any cancellation from January 7, 2025 thru February 5, 2026
- 90% of cruise fare in USD for any cancellation from February 6, 2026 thru February 25, 2026
- 100% of cruise fare in USD for cancellation from February 26, 2026 to date of sailing

PLEASE NOTE:

Costa insurance is available up to 75 days prior to sailing to US citizens. Tango at Sea offers Door to Door travel insurance through Allianz Travel Insurance to citizens in the USA. Premiums are based on cost of travel plus the age of the traveler. Full details are listed under the Travel Insurance tab on our website. **Our guests are required to carry travel insurance.**

REFUNDS: Requests must be made in writing by email ONLY. Processing time for refunds will occur after the sailing ends on March 27, 2026. Deposit receipt, cruise tickets, airline tickets, transfer coupons and all other vouchers must be returned to Tango at Sea before a refund can be made. In most cases the refund will be processed via Tango at Sea company check. Administration fees must be paid to Tango at Sea Agency before cruise cancellation can be completed.
